LIMITED WARRANTY

- I LIMITED WARRANTY: Victory Components, warrants its RV products to be free from defects in workmanship and materials, and limits the correction to repair or replacement.
- II WARRANTY PERIOD: This warranty shall be for a period of TWO YEARS from the original date of purchase by the original owner. This warranty will transfer to the subsequent owners for the unexpired period.
- III PROOF OF PURCHASE: Proof of purchase date by the Original Owner will be the responsibility of the Current Owner and must be supplied along with the Warranty Claim.
- IV CLAIM PROCEDURE: All warranty claims will be handled directly thru an approved Victory Components R.V. Dealer and is Valid only within the continental limits of the United States and Canada.
